### 1. Purpose

V	> 2,000	<ul style="list-style-type: none"> <li>Level IV benefit</li> <li>Organization booth at all AMPAG events within a year</li> <li>Eight VIP guest tickets for every AMPAG events within a year</li> </ul>

(2) **Event Sponsorship:** sponsor a specific event organized by AMPAG in the form of monetary, material, or other resources upon mutual agreements with AMPAG.

Event Sponsorship Amount Levels and Benefits:

III	> 1,000	<ul style="list-style-type: none"> <li>Level II benefit</li> <li>Organization booth at the event</li> <li>Six VIP guest tickets for the event</li> </ul>
